Hi Pat:

We had a packed agenda last week so I thought it wise to hear where Folger Pratt was coming from and hear staff comment on it and of course anyone on the task force could have waded in on the proposal but no one did--then--and I didn't think we were ready to vote on anything. I also didn't want to get into a discussion with the audience as we have set rules for public comment, had a time crunch and secondly it, this new proposal of his, needs to be seasoned and boiled down by a community discussion before Folger Pratt comes back and we get into it. At that time we'll be in a much better place on being able to take next steps on the site. Also we will have almost an entire meeting to receive public comment and I'm sure that we will hear plenty of individuals views on the site. I agree with you that the site needs to be set right. The community needs to be in a good place with it.

On the issue of the school, there is something in the works for a new school outside of this immediate area--but one that will serve the needs we will create.

Penny and the school administration is working on it now. I can relate it to you

and what it all entails but not in an email. We should steer clear of proposing specific schools as the boundaries constantly change & etc. But, making a statement that a school(s) maybe/will be necessary due to the changes in the 7 corners residential density is something that we can add into the public facilities language. It might even help the proposal now in the works. If the community wants to make the case for additional school space I'd say go for it.

On the light, you should state your views just as I and anyone else on the TF does, and let Mike or Chris respond. I am not familiar enough with the circumstances of the intersection so will look to you and the other community members for reality here, and I think that the other members will do the same.

Hi John - two quick updates:

1) Ravenwood Park (RPCA) is going to focus on school overcrowding issues. I have told them that school needs were not explicitly part of our charter since school overcrowding issues and a new elementary school were already in the works

by FCPS when the task force was created. However, I pointed them to the Seven Corners plan amendment "pre-screening" Agency reviews on the website where FCPS states the density increase will drive the need for a "new elementary school" as well as "additions to the middle and high school." Do you expect the task force to ever more explicitly address the school overcrowding issues that would be worsened by the density increases or to continue to point them to ongoing work by FCPS and to the requirement for FCPS to formally review the plan amendment?

2) You did not allow us to share our thoughts on Knapp's updated Sears site concept at the last meeting (which was surprising to me since I spent so much time on it in the previous two week period) but one issue I had (which I shared with him) was his proposal to add an outlet from Juniper Lane in the new development to Patrick Henry by adding a stop light in the middle of the short hill on Patrick Henry which I thought was dangerous and which FCDOT also had previously stated was not possible during the design charrette. RPCA is likely to voice strong opposition to that new traffic signal (conversely, the neighborhoods that border the Sears site strongly desire the new signal so that they don't have to drive through the heart of the new development). I plan to tell them that FCDOT is very unlikely to approve that new signal unless you tell me otherwise?
