Regarding the minutes, I'd appreciate it if we could add the fact that I raised concern about the two graphics in the Plan that suggest relocating the intersection on Arlington Boulevard that is current to the east of the Target's east entrance to a new location at Olin Drive. I said that opening up Olin Drive directly to Arlington Boulevard and the Target would significantly increase cut-through traffic on what is now a quiet street of single-family homes.
